The Fiscal Court in and for Todd County met in regular session at the Courthouse at 9:04 a.m. and the following proceedings were had: The following Magistrates were present:

Alfred Blake, Rex Johnson, John Camp, Jimmy Turner and Brent Spurlin

The Court opened with the pledge of allegiance, followed by a prayer by Daryl Greenfield.

- Upon motion of Squire Spurlin, seconded by Squire Camp, it is hereby ordered to approve the March 25<sup>th</sup>, 2011 Fiscal Court minutes and file.

Passed on a voice vote

---

- Upon motion of Squire Spurlin, seconded by Squire Johnson, it is hereby ordered to approve transfers for April 8th, 2011.

- Accounts Payable was presented to the Court for review and it is hereby ordered to file and pay all bills subject to state audit.

- Upon motion of Squire Turner, seconded by Squire Blake, it is hereby ordered to approve the March 2011 Financial Report subject to state audit.

- Todd County Treasurer, Tammy Robertson, announced the Todd County Clerk's office turned in an additional \$454.18 in excess fees for the 2010 year. This was from collection on cold checks.

- Upon motion of Squire Camp, seconded by Squire Turner, it is hereby ordered to approve transferring \$5000.00 from Sheriff Deputy Line to Equipment Line in the Sheriff Budget.

- Upon motion of Squire Johnson, seconded by Squire Spurlin, it is hereby ordered to approve amending \$2310.00 into the Sheriff Equipment line on expenses and \$2310.00 into the reimbursement line on revenues. Money was donated to Sheriff Department by Todd County Drug fund to purchase tasers.

- Upon motion of Squire Spurlin, seconded by Squire Turner, it is hereby ordered to approve Jason Heltsley as a part time EMT at \$9.25 per hour.

- Pete Steger is retiring at the ambulance service leaving a need for an assistant ambulance director. It was recommended by Timothy Wells, Todd County Ambulance Service Director, to appoint Roger Cropper to this position at no additional salary. It was agreed by the Court.

- Upon motion of Squire Spurlin, seconded by Squire Turner, it is hereby ordered to appoint Eric Campbell as interim EMA Director until the Court hires a replacement for Bradley Powell. There is no salary for Mr. Campbell at this time.

- Judge Greenfield asks that Squires Turner and Johnson sit in on interviews and possibly recommend a name to the Fiscal Court at the next meeting.

- Bids will be opened April 15, 2011 for asphalt that will carry us for the next 90 days and finish out the fiscal year.

- Upon motion of Squire Blake, seconded by Squire Turner, it is hereby ordered to approve shortening N David Hightower Road by .484 miles.

Donnie will serve as Animal Control Officer with \$8400.00 of his salary coming from the general fund and will report to the road department daily as an employee with CDL's and the remaining \$13,600.00 of his salary coming from the road fund. This will be on a 90 day trial.

- County Attorney, Mac Johns, reported that April 15, 2011 will be the last day the Sheriff Office will be collecting taxes. They will be turned over to the Clerk's Office at which time there will be additional fees and penalties.

- Upon motion of Squire Spurlin, seconded by Squire Camp, it is hereby ordered to approve the Todd County Clerk's 1<sup>st</sup> quarterly report subject to State audit.

- Todd County Sheriff, Joey Johnson, presented the Court with a March 2011 monthly report and an activity report showing January-March activities for the Sheriff Department.

- Upon motion of Squire Turner, seconded by Squire Camp, it is hereby ordered to approve participation in the TVA Lighting Grant. A dollar amount will be determined at a later date.

- Upon motion of Squire Spurlin, seconded by Squire Turner, it is hereby ordered to approve reappointing Todd County Treasurer, Tammy Robertson, to a 4 year term beginning July 1, 2011 through June 30, 2015.
